To whom it may concern:

Please allow me to say a little bit about Gail Fitzer-Schiller, a very capable and dedicated journalist I have known since 1991.

I first met Ms. Fitzer when I was editor-in-charge of the foreign exchange desk at Reuters in New York. She was assigned to this desk under my supervision although she was more of a general news reporter and had relatively little experience in financial journalism.

Ms. Fitzer proved to be a very quick study and in a matter of a few weeks was up to speed writing stories about the wild gyrations of the currency markets and relating them to the underlying global economic interplay such as trade imbalances, fiscal and monetary policy in the major countries and political upheaval.


She was very good at writing a story under deadline pressure that simplified the issues without making them too trivial. She could write the trend story as well as the spot story with equal ease. She was also good at developing contacts among the many foreign banks in New York which are a key part of this market.

More recently, I have been editor-in-charge of the Reuters Wall Street office. During this time Ms. Fitzer has been the specialist responsible for covering the U.S. pharmaceutical industry. This beat is normally a difficult assignment, requiring knowledge of major drugs under patent and their effects on the profits of the companies; an appreciation of where the competition is hottest to find new drugs; the process by which drugs are tested and submitted for approval, and finally the impact of generics. But lately the controversy over health care reform has made all of this much more complicated.

Ms. Fitzer has developed sources among the Wall Street analysts and at the key companies and has produced a solid string of exclusives as well as keeping up with a heavy load of daily routine which has to be produced under deadline pressure.

I believe Ms. Fitzer would be an asset to any kind of news operation where good writing, speed and the ability to develop sources and produce exclusive stories are in demand.

I am happy to recommend Gail Schiller for her reporting, writing and editing talent. Although it has been more than a decade since we worked together, and I cannot speak for her work since then, I remember that she asked good questions, wrote sharp copy and made others' copy better.

We worked together in 1986-90 when I was the desk head and she was a correspondent at the Reuters News Agency bureau in Israel. She was fresh out of university at the time, but her work matched that of more senior people. Her byline then was Gail Fitzer.

She worked well under pressure, meeting an ever-present deadline covering what is often the biggest, fastest-moving story in the world. She was accurate and fair in her coverage, and quick, and skillful at recording the nuances of Israeli politics and international diplomacy.

She was fearless about asking questions. I remember her asking then-Prime Minister Yitzhak Shamir tough questions that produced good stories. While with Reuters in Israel, she traveled with the prime minister, including on an official trip to Romania.

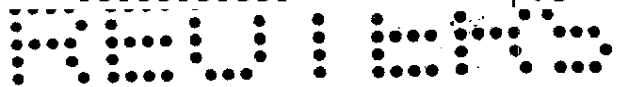
